APRIL IS CHILD ABUSE PREVENTION MONTH

PLANT A PINWHEEL FOR A CHILD

In 1983, Congress declared April as National Child Abuse Prevention Month. Since then, communities nationwide have seized the opportunity to raise awareness about issues surrounding child maltreatment and abuse, particularly during April. Planting a pinwheel garden is one effective way our community can raise awareness about this problem.

The pinwheel serves as the symbol for child abuse and neglect prevention, representing the stable, healthy childhood all children deserve. Placing pinwheels in yards or businesses helps spread awareness in our community, emphasizing that child welfare is a collective responsibility for everyone, contributing to children's healthy development and growth.

April provides an ideal time for our community to reflect on the children who have suffered and the losses incurred due to such suffering. In the last fiscal year, from July 2022 to June 2023, the Child Advocacy Center provided services to 811 children referred to us for abuse allegations. April also prompts us to look forward, envisioning a future where children no longer live in fear, but in safe and nurturing environments, free from abuse.

Our children represent our most precious resource, deserving to grow up in environments devoid of threats, dangers, and the harmful effects of abuse and neglect. Unfortunately, many children do not experience this reality. April serves as a reminder that regardless of individual challenges, prioritizing the welfare of all children must remain our foremost concern.

By planting a pinwheel garden, you demonstrate support and raise awareness, signaling that everyone shares a role in fostering safe communities for our children.



WHAT WE DO

A Place of Healing and Hope: Joining hands with community agencies, the Child Advocacy Center (CAC) offers a safe and child-friendly place to interview and provide supportive services for child victims of abuse. The CAC also provides prevention education for parents, professionals, and agencies in our community. We look to a future where all children live in a safe and nurturing environment free from abuse.

During FY 2023, the Child Advocacy Center received 811 cases of reported child abuse. 491 forensic interviews were conducted at the Center. 638 families received Victim Family Advocacy Services, providing direct aid as well as assisting them in accessing needed resources. 127 children attended individual counseling and 21 children participated in group counseling. 1130 people received child abuse prevention and awareness education. Volunteers contributed 1968 hours of service to the CAC. For additional information, please visit CACFAYNC.org.
