




# Child Advocacy Center Benefactor Sponsorships

If you were to count the number of times you were asked to sponsor charitable events last year, what would that number be? Probably too many to count. While the past couple of years have been challenging for all of us, despite the challenges presented, we remain open and committed to providing needed services to child victims of abuse and their families. Unfortunately, our caseload has grown significantly.

The Child Advocacy Center (CAC) offers our community partners an opportunity to make an annual sponsorship contribution while receiving the benefits of year-round recognition. Benefactors are recognized as sponsors for our two signature fundraising events: the Pinwheel Masquerade Ball & Auction in the fall and Fayetteville's Ultimate Lip Sync Showdown in the spring, as well as receiving additional public acknowledgment and appreciation from the CAC.

So how will your sponsorship positively impact our community? Your contribution will help ensure the ongoing sustainability of the CAC, as the unrestricted proceeds from our fundraisers help defray our operational costs. The CAC is a 501(c)(3) organization that provides a safe, child-friendly place where law enforcement and community agencies come together to interview victims of child abuse and coordinate the best possible support for abused children. In fiscal year 2023, the CAC served 811 children and their non-offending family members. Additionally, the CAC provides education to the public and professionals on preventing, detecting, and reporting child abuse.

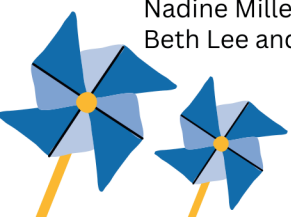

## Stories About Our Children

This past fiscal year, the Child Advocacy Center served 811 child victims of abuse. Do these numbers shock you? The thought of even one child suffering from abuse is horrifying- much less 811! There is an apparent need in our community for the services that the Child Advocacy Center provides.

When we see a number like this, it is easy to become discouraged about the fate of vulnerable children in our community, but there is hope! At the CAC, our mission is to provide a safe, secure and child-friendly location where children can share their experience of abuse, receive help and begin the process of healing.

One way we have offered children hope and healing this year is through our group counseling program. Many studies have shown the strong relationship between childhood trauma and serious health outcomes, including post-traumatic stress disorder, depression, physical health problems and even early death. Evidence-based mental health treatments can significantly reduce the long-term effects of exposure to trauma and improve the lives of children.

Therapeutic groups for girls have been a part of our onsite services since 2016. In 2019, for the first time, some of our girls have participated in three ongoing levels of group counseling. The initial phase, called Voices, focuses on healing from trauma. The second level, Girls' Circle, helps the girls reestablish trust and connections with others. The third level, new this year, is People Empowering People, where the girls learn about making a difference in their community.

During the Fall of 2020, we added a boys' group called Growing Healthy, Going Strong, which got started when the brother of a girls' group member asked our counselor why there wasn't a group for boys. He had heard such great things from his sister! Our counselor enlisted the help of a male facilitator who is a musician, and together they developed a group incorporating creative arts into therapy. The boys are encouraged to record their feelings in journals, turn their words into a song or rap, and perform for each other. The first week, only four of the nine boys performed. By week seven, all the boys were writing and sharing their lyrics with the group.

These children are progressing on their journey of healing thanks to the coordinated efforts of caring family members, law enforcement, social services, counselors, the CAC and YOU through your generous financial support.

## Did You Know?

- A child is abused or neglected every 48 seconds in the United States. (Children's Defense Fund - The State of America's Children 2021)
- Some experts estimate that as many as 1 in 10 children will be sexually abused before they reach the age of 18. (Darkness2Light)
- There are an estimated 42 million survivors of sexual abuse in the United States. (Darkness2Light)
- Cumberland County consistently ranks in the top three counties in North Carolina in the number of children investigated for maltreatment.
- The Child Advocacy Center is one of only 51 accredited Children's Advocacy Centers in North Carolina and for the past 31 years has been a place of healing and hope for thousands of child abuse victims and their families in Cumberland County.

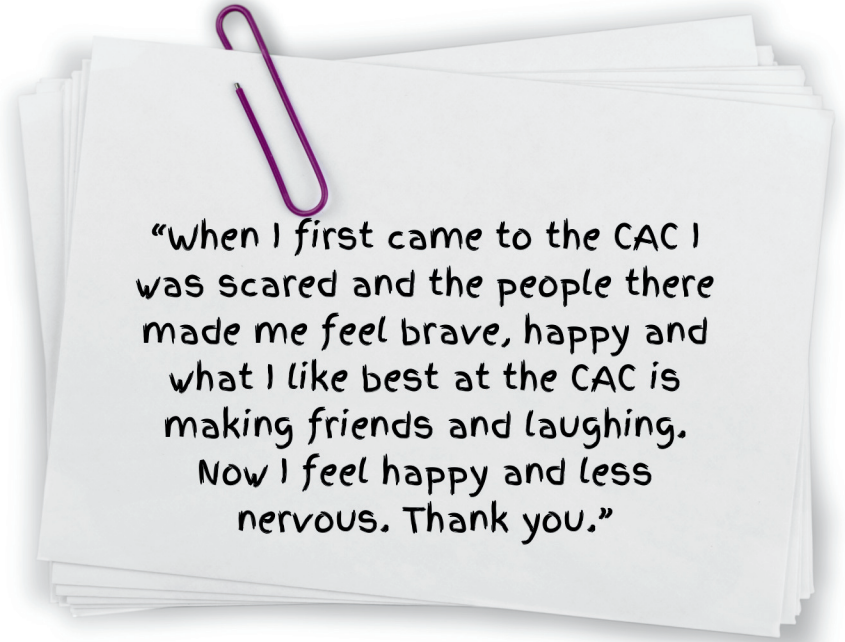

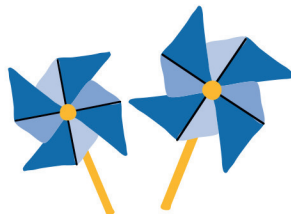
