We collaborate with community partners to respond to and prevent child abuse



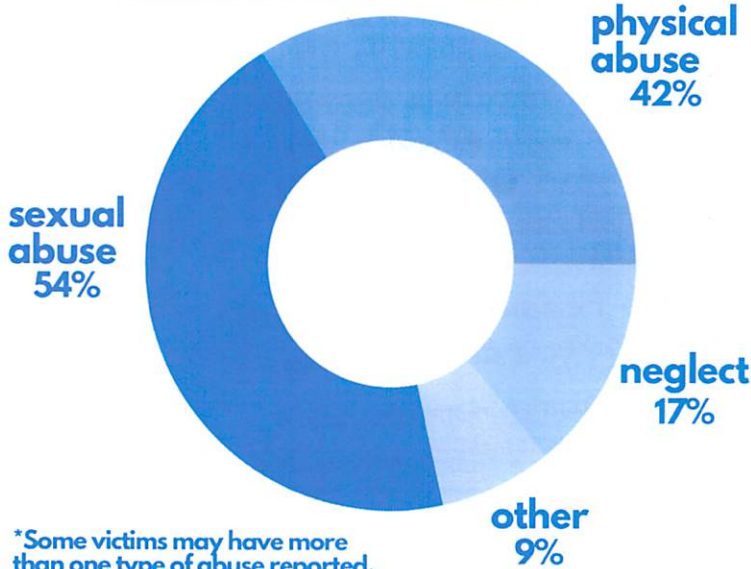
811 cases of reported child abuse were referred to the CAC
(3% Military Dependents)

60% of the children seen were females
40% of the children seen were males

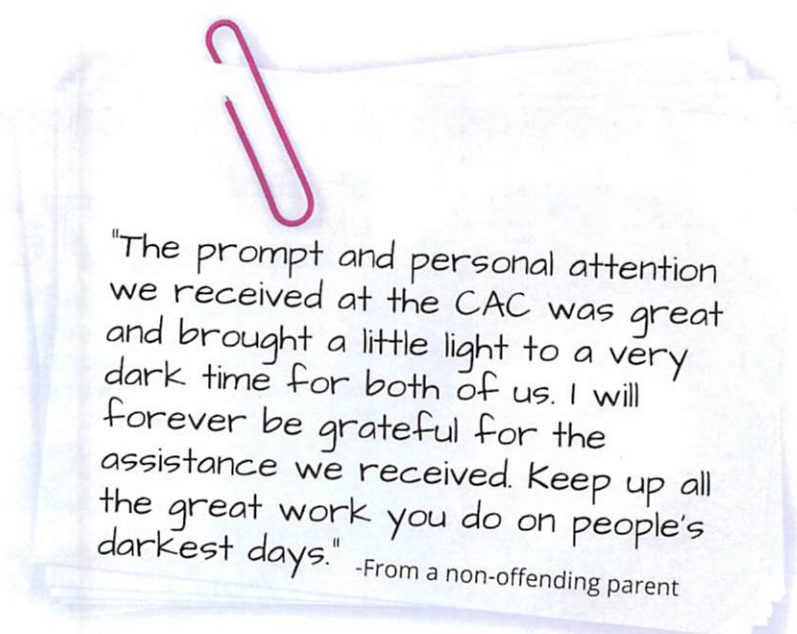
